

# Terms and conditions: Allocation of tickets for NUMIX LAB – international event for digital creativity

The Vienna Business Agency is giving away tickets to <u>NUMIX LAB</u>, an international event for digital creativity taking place on 4 and 5 December 2025 in Vienna (and optionally also in Linz on 5 December), to interested Viennese creative entrepreneurs, creative start-ups and creative professionals with start-up intentions who want to network at the event.

The tickets, worth EUR 260 each, will be provided in the form of a promo code and can be redeemed by the selected applicants themselves on the event website at <a href="https://my.weezevent.com/numix-lab-2025-Budapest-Veszpr%C3%A9m-Vienne">https://my.weezevent.com/numix-lab-2025-Budapest-Veszpr%C3%A9m-Vienne</a>.

It is also possible to use the promo code to book a discounted ticket (EUR 220 instead of EUR 480) for the entire week of events in Vienna, Linz, Budapest, and Veszprém (Hungary) instead of tickets for the events in Vienna (and Linz).

## Who can participate?

The offer is aimed at creative entrepreneurs and creative professionals from Vienna who intend to start a business. Any natural person of legal age residing in Vienna who intends to start a business in Vienna and any legal entity with its registered office or place of business in Vienna is eligible to participate.

Applications that do not meet these conditions of participation cannot be considered and are therefore excluded from participation.

### Details on the application

Applications can be submitted <u>online at this link</u> until **21 September 2025**. Information about the participant's motivation and the (future) company is required for participation in the program.

In return, the selected participants agree to:

- Participate in the event
- Agree to the taking of photographs during the event and the use of these photos by the Vienna Business Agency for advertising purposes.

Only applications that are submitted on time and are fully completed will be considered.

#### Selection

Participants will be selected from the valid applications according to the following criteria:

- Motivation for participation based on the letter of motivation
- Special attention will be paid to the diversity of the participants

Information about the allocation of tickets will be provided by Wednesday, 24 September 2025 at the latest.

The allocation of tickets constitutes aid within the meaning of Articles 107 and 108 TFEU. This aid is granted under Commission Regulation (EU) No. 2023/2831 of December 13, 2023, on the application of Articles 107 and 108 TFEU to de minimis aid. This is de minimis aid that does not exceed the maximum amount specified in this Regulation. Before accepting the tickets, the winners of the raffle are required to complete a de minimis declaration confirming that the prize constitutes de minimis aid within the meaning of Articles 107 and 108 TFEU. The declaration serves to clarify whether and to what extent the granting of further de minimis aid is permissible under EU regulations. The total amount of de minimis aid granted to an enterprise may not exceed EUR 300,000 over a period of three fiscal years.

### **Data protection**

The Vienna Business Agency processes the personal data provided (name, company/company registration number, address, telephone number, email address, URL) by the applicants on the basis of their consent and in order to fulfill a legal obligation. The processing of this data is also permitted after the selection process has ended, provided that this is necessary to safeguard the legitimate interests of the Vienna Business Agency or to fulfill a legal obligation. By submitting your application, you agree to the above conditions of participation. There will be no cash redemption. Participation in the selection process is free of charge. There is no legal entitlement to tickets.

The conditions of participation will be translated into English. However, only the German version is legally binding.
